Dear Iowa State University faculty and staff,

As part of the university's regular review of employee health care benefits, changes will be made to health care premiums for 2025. These adjustments are necessary to address ISU's rising medical and pharmacy claims expenses and the ongoing inflationary rise in health care costs here in Iowa and across the nation.

Iowa State University is committed to providing competitive, affordable health care benefits to support you and your family. To minimize the impact on employees, the university will absorb the majority of the premium increases and will continue to cover more than 87% of the total cost of the health care plans.

The new employee monthly premiums will take effect January 1, 2025, as shown in the chart below. No changes are being made to health care plan designs. Overall health care coverage will remain the same.
